HEREBY AGREE with the persons, organisations and bodies corporate whose names appear in schedule (hereinafter collectively called 'the organiser' ) that I am by signing this agreement, agreed to the terms and conditions which entitle me to ride a motor cycle at the venue at Long Point Reserve referred to in the schedule (hereinafter called 'the venue') on the terms and conditions set out in this document.

**ACKNOWLEDGMENT OF RISKS, DANGERS AND OBLIGATIONS**

2. I ACKNOWLEDGE that motorcycle sport is dangerous and by engaging in the sport and riding at the circuit I take and am exposed to certain risks and dangers and am under certain obligations as follows:
- a) that I may be injured physically or mentally, and may be killed;
  - b) that my machine or equipment may be damaged lost or destroyed;
  - c) that other riders may ride dangerously or with lack of skill;
  - d) that track or event conditions may be hazardous and may vary without warning or predictability;
  - e) that organisers, officials, landowners/track operators and any agents or representatives of those in charge of the track/venue have only agreed to let me ride on these terms and conditions;
  - f) that any insurance protection is not available to me or provided by the landowner or the Club;
  - g) that there may be no or inadequate facilities for treatment or transport of me if I am injured;
  - h) that I have an obligation to myself and to others to compete safely and within the rules of competition.

**INDEMNITY GIVEN TO ORGANISERS**

3. IN CONSIDERATION of the acceptance of me to ride at the venue I AGREE TO INDEMNIFY the organisers and each of them in the following manner :
- a) that I am riding at the venue at my sole risk and responsibility;
  - b) that I accept the venue and the track condition as it stands with all or any defects hidden or exposed;
  - c) that I indemnify and hold harmless the organisers, their respective servants, agents or officials against any action or claims which may be made by me or on my behalf or by other parties for or in respect of or arising out of my death or any injury, loss or damage caused to me or my machinery or equipment whether caused by negligence, breach of contract or in any other manner whatsoever.

**CONDITIONS OF RIDING AT THE VENUE**

4. Riders acknowledge and agree that the following conditions are the conditions for the right to ride at the venue and that the landowner and the Club will rely on this document in the event of injury or loss to the rider or his/her equipment.
- a) I am a financial member and will continue to pay my subscription.
  - b) I have signed this form voluntarily, understand it fully and accept the conditions of being allowed to ride.
  - c) If a senior rider I will always have a companion with me, who will supervise me when I ride.
  - d) If a junior rider, my parent/guardian will always be present when I am at the venue to supervise me.
  - e) I will only ride in the area / tracks designated for me.
  - f) I will only ride to my ability and will obey the rules of the Club including only ride anti-clockwise, not cut the track whilst riding and will not ride in the car park.
  - g) I will give way to other vehicles and pedestrians/spectators in the car park.
  - h) I will always ride to the conditions of the track and agree to complete one site lap on each occasion I commence my ride.
  - i) All bikes are to be in Safe working , Silenced, scrutinized
  - j) I will obey Track Marshalls instructions at all times
  - k) Protective clothing to be worn while riding at all Times [Helmet, Gloves, Boots, Goggles, Long pang Pants a sleeved short
  - l) Must show membership card to marshal at sign in point
  - m) Local fire restriction must be adhered to at all times no fires are to lit in the pit area or open
  - n) Riders not abiding by these rules WILL BE PENALISED
